

## **5 Simple Steps to Request Initial Disclosures**

With the implementation of T.R.I.D on 10/3/15 Angel Oak Mortgage Solutions must issue disclosures on all broker loan applications. **No later than 2 days from the 1003 date** the broker should follow these simple steps to request the disclosure package:

**Step 1:** Submit a Loan Scenario Request (LSR) on the Angel Oak website.
